- Draw a sketch of the scene – take photos if possible
- Note everything you can – All witnesses, locations, damage and circumstances
- Be sure to note the make, model, colour and registration of each vehicle involved
- Remember to look out for other traffic around the accident, particularly on busy highways

## QMT Accident Assistance & Legal Service

This service is administered by Mooney Everett Solicitors Ltd. In the event of a non fault road traffic collision we will manage your claim against the third party insurer and help you recover any losses incurred. Our experience will ensure that your case is handled efficiently from inception all the way through to settlement. We will liaise with all insurers involved on your behalf together with any witnesses, engineers and repairers and manage any court proceedings or medical practitioners where necessary.

## Accident Management Service

If the Road Traffic Collision was not your fault, we can:

- Arrange repairs via your chosen repairer or from an approved repairer network.
- Arrange a replacement dual controlled like for like vehicle.
- Provide emergency roadside assistance.
- Arrange a replacement windscreen or repair.
- Deal with any injury claims on behalf of you and any passengers and arrange physiotherapy treatment.
- Protect or reduce insurance premium increases.
- Submit and mitigate any loss of earnings or compensation claims incurred as a result of the accident.

## Litigation Service

Legal Assistance will be provided if Mooney Everett Solicitors Ltd are of the opinion that you have reasonable prospects of recovering damages.

### Prospects of Success

We may give you written notice if during the course of the claim we feel that there are no longer any prospects for success. Legal Assistance may be withdrawn subject to notice if after due consideration of your claim, the legal costs in pursuing the claim outweighs the damages to be recovered.

## Vehicle Repairs Service

If the accident was not your fault, we will arrange the assessment, authorisation and repairs. If your vehicle is deemed un-roadworthy we can arrange an immediate temporary replacement dual controlled vehicle with insurance to be delivered to your door whilst your own vehicle is off the road, or being repaired. If repairs are authorised and arranged by us you may have no excess to pay. We will manage your repair process or total loss claim and keep you informed of the progress to allow you to continue working as normal.

## Replacement Vehicle Service

In the event of a non fault accident we will arrange for you to be supplied with a replacement dual control vehicle, with insurance, whilst your own vehicle is off the road, or being repaired.

In the event of a fault road traffic accident, we will arrange a replacement dual control vehicle for a maximum period of 21 days.

Replacement is subject to availability and the following terms and conditions: The fault accident must be reported to the QMT claims line within 14 days. No other hire or replacement vehicle has previously been supplied, by any party. Payment of additional insurance charges may apply.

## Terms & Conditions and Eligibility

Legal Assistance will only be provided by Mooney Everett Solicitors Ltd under this service following a road traffic collision and will not cover any costs associated with any alternative legal services provider. Claims must be reported within 6 months of the accident.

In order for assistance to be provided, your motor insurance policy must be in order and not due for cancellation.

### Exclusions

This cannot be used to pay any excess payment.

This service cannot be used against malicious damage, vandalism, mechanical breakdown or windscreen claims.

Claims outside of the UK. Isles and Ireland subject to extra charges.

### Regulation
